A. CONTEST DATE AND TIME.

1. Registration Dates: Registration will begin at approximately 12:00 pm on July 31st, 2025, and end at approximately 8:00 pm on September 6th, 2025.
2. Early Registration: Early registration will begin at approximately 12:00 pm on July 31st, 2025, and end at approximately 8:00 pm on August 20th, 2025.
3. Contest Times: The selection window will begin at approximately 10:00 am each Wednesday of the Contest and will end at approximately 8:00 pm each Saturday of the Contest. The Contest held on Thursday, November 27, 2025, will begin at approximately 10:00 am Tuesday, November 25, 2025, and end at approximately 8:00 pm Wednesday, November 26, 2025. The Contest held on Thursday, December 25, 2025, will begin approximately 10:00 am Tuesday, December 23, 2025, and end at approximately 8:00 pm Wednesday, December 24, 2025.
4. Length of Contest: The Contest will be held for twenty (20) weeks or until all eligible participants are eliminated. The Contest will end no later than approximately 8:00 pm on Wednesday, January 7, 2026. The Contest will be considered official after week 8 of the NFL season. If the Season does not run for 8 weeks, the contest will be cancelled, and all entry fees will be refunded.

B. METHODS OF ENTERING.

1. Open to all PENN Play rewards members.
2. No more than one-hundred (100) entries will be accepted.
3. The buy-in for the contest is \$500 per entry. Entries can be paid in cash or PENN cash.
4. Early Registration Participants will receive \$50 PENN cash for every entry placed during the early registration period (July 31st, 2025 - August 20th, 2025).
5. Payment of entry fees, which must accompany registration for the Contest, begins at approximately 12:00 pm on July 31, 2025. Contest registration and entry payment paperwork will no longer be accepted after approximately 8:00 pm on Saturday, September 6, 2025.
6. All entrants and proxies must be at least 21 years of age to participate. Entrants must provide valid government picture identification prior to entry of contest. All submitted entries are subject to potential 3rd party verification. All entrants must also be a current "PENN Play" member. If the guest is not a PENN Play member, the guest can sign up for a PENN Play card at Player Services or ESPN Bet Sportsbook. Signing up for a PENN Play card is free.

C. OTHER CONTEST PROCEDURES.

1. Entrants may purchase a maximum of five (5) Entries per person. Purchasing more than five (5) Entries will result in disqualification from the contest without a refund. Entrants who have multiple entries earning prizes will be paid for each entry's corresponding prize dollar amount.
2. Each entrant may authorize up to one (1) proxy to submit their weekly selections. Proxies must be

registered in person at Hollywood Casino at Greektown and must satisfy the same ID requirements (*see Section B.12 of the NFL Survivor Official Rules*).

3. Hollywood Casino at Greektown does not officially endorse or recommend any Proxy or proxy service and shall not be involved in any Proxy agreement under any circumstance. Furthermore, all participants assume sole liability of submitting their weekly selections, whether a Proxy is registered or not. Hollywood Casino at Greektown will under no circumstance mediate between any Entrant and any Proxy.
4. Failure to make a selection during the selection window will result in elimination from the contest (*see Section B.13 of Sportsbook Survivor Pool Official Rules*).

D. METHOD OF WINNING.

1. The Contest is won by being the last remaining contestant with a correct selection during the NFL season. Losing weekly selections will cause an entry to be eliminated from the Contest. Weekly selections will be made on NFL teams to win without the use of a point spread. Entrants may only pick each professional football team (NFL) one (1) time throughout the duration of the Contest (example: an Entrant selects Team A to win during Contest Week 1 of the professional football season. Team A will no longer be available for selection for the duration of the Contest). Weekly selections shall be graded as a loss if the selected team ends their game in a tie.

E. TYPE AND AMOUNT OF PRIZES TO BE AWARDED:

1. The prize pool will be funded with Contest entry fees.
2. All prize payouts will be made in cash or check.
3. At the conclusion of each Contest Week, all Entrants with an incorrect selection are eliminated. The Contest proceeds or the Contest Winner(s) is/are then determined as follows:
 - i. If more than one Entrant remains Active and at least one Contest Week remains, all remaining Active Entrants continue to the next Contest Week.
 - ii. If only one Active Entrant remains at any point during the Contest, that Entrant is the Contest Winner, regardless of the Contest Week in which this occurs. If at least one Contest Week remains, the Contest continues only with respect to the Undefeated Bonus Prize.
 - iii. If zero entries remain, the Contest ends and the prize pool will be split equally among all Active Entrants that submitted a correct selection in the immediately preceding Contest Week, regardless of the Contest Week in which this occurs.

- ii. If multiple Entrants provide correct selections for all 20 possible Contest Weeks, both the prize pool and Undefeated Bonus Prize will be split equally among those Entries.
- iii. If the NFL season is shortened for any reason, or there are not 20 complete Contest Weeks as determined by Hollywood Casino at Greektown and these Rules, there will be no Undefeated Bonus Prize awarded.

A. Definitions.

For purposes of these Official Contest Rules ("Rules"), the following definitions apply:

1. "Entrant" is a person that enters the Contest.
2. "Alias" is the name selected by an Entrant used to identify the Entrant in the official standings or for other public purposes in connection with the Contest.
3. "Proxy" is a person authorized by an Entrant to record and submit a Selection Form on their behalf.
4. "Active" is the status of an Entry or Entrant that has not been eliminated, disqualified or removed from the Contest.
5. "Inactive" is the status of an Entry or Entrant that has been eliminated from and is no longer Active in the Contest.
6. "Selection Form" is a document on which weekly selections are recorded by an Entrant or a Proxy.
7. "Selection Window" means the time period during which the Selection Form must be submitted during a Contest Week to be eligible.
8. "Registration Form" is a list of fields on which an Entrant inputs data pertaining to the Contest.

B. Contest Rules

1. Registration for the "Greektown Sportsbook Pro Football Survivor Contest" (hereinafter the "Contest") will begin at 12:00 PM on July 31, 2025, at the Hollywood Casino at Greektown Sportsbook (555 E. Lafayette St, Detroit MI, 48226). All references to time of day refer to local time (EST).
2. There is a \$500 fee per entry ("Entry" or "Entries"). All entry fees are non-refundable unless the Contest is cancelled as provided for in these Rules. Entry fees may only be paid with cash at the Hollywood Casino at Greektown Sportsbook desk.
3. To be eligible to participate in the Contest, all Entrants must (i) be at least 21 years of age; (ii) be a Penn Play member; (iii) not be an Ineligible Person (as defined in Hollywood Casino at Greektown's Official Promotion Rules effective as of 02-12-21("Official Promotion Rules")), which are available at the Hollywood Casino at Greektown Sportsbook desk and www.hollywoodgreektown.com); and (iv) meet all

other requirements and criteria set forth in these Rules. Entrants may be asked to provide additional information for Hollywood Casino at Greektown to confirm their identity and eligibility. Hollywood Casino at Greektown makes the final determination at its sole discretion as to who is eligible to participate and/or win the Contest. Entrants agree to abide by these Rules and by the decisions of Hollywood Casino at Greektown, which are final and binding in all respects.

4. Entrants may purchase a maximum of five (5) Entries. Purchasing more than five (5) Entries will result in the entrant being disqualified from the Contest without any refunds.
5. All Entrants are eligible for \$50 PENN Cash for every entry received during early registration. Early registration is defined as July 31st – August 20th.
6. Entrants will select an Alias at registration for each Entry. Hollywood Casino at Greektown reserves the right to reject any proposed Alias for any reason at any time. If Hollywood Casino at Greektown decides to change an alias after the sign-up process is complete, Hollywood Casino at Greektown will make a reasonable effort to contact the Entrant to give them an opportunity to provide a replacement for Alias. In the event no Alias is provided, or no Alias is provided that is acceptable to Hollywood Casino at Greektown, the Contest ID number will be the official name of the Entry, and that ID number will be displayed in all official standings and/or prize documents.
7. Registration, which requires payment of entry fees and submission of a completed Registration Form, begins at Hollywood Casino at Greektown Sportsbook at 12:00 PM on July 31, 2025, and ends at 8:00 PM on September 6, 2025.
8. To play the Contest, an Active Entrant must complete and timely submit for each week of the NFL regular season (plus Thanksgiving & Christmas) a Selection Form on which the Entrant or its Proxy selects one NFL team to win a game played on a Friday, Saturday, Sunday or Monday (and Thanksgiving & Christmas Day) for the specified week. Entrants may only pick each NFL football team one (1) time throughout the duration of the Contest for each Entry (example: an Entrant selects Team A to win during Contest Week 1. Entrants may no longer select Team A to win a game for the remainder of the Contest for that Entry. Losing weekly selections (which means the team selected by Entrant on the Selection Form either loses or ties to the game) will cause an Entrant to be eliminated from the Contest for that Entry. The Contest is won by the last remaining Active Entry(ies) at the end of the Contest as defined in these Rules.
9. Entrants will complete up to 20 Selection Forms for each Entry to this Contest. For Contest purposes, Thanksgiving & Christmas Day (November 27th, 2025 & December

- 25th, 2025) will be its own independent “Contest Week”, referred to herein as the Thanksgiving Day Contest Week & Christmas Day Contest Week. The other 18 “Contest Weeks” will otherwise correspond with the NFL regular season Friday, Saturday, Sunday or Monday game schedule.
10. Entrants who have previously selected all 6 teams that will play on Thanksgiving & Christmas Day and are therefore unable to select any of the teams playing on Thanksgiving & Christmas Day, will be eliminated from the Contest at the conclusion of the Thanksgiving Day Contest Week for each such Entry.
 11. Entrants with multiple Entries may make contradictory selections across their multiple Selection Forms. Each Entry will be treated independently for purposes of this contest.
 12. If a game deviates from its originally scheduled time and location, the game must be completed by the end of the Contest Week (1:59 AM (local time) on Wednesday) in order for it to be applied towards Contest standings. Games that are not completed by such day and time will be graded as a loss for the Contest, and the Entrant will be eliminated from the Contest for each such Entry. A “Contest Week” means seven (7) consecutive calendar days starting on Wednesday at 2:00 AM and ending on the following Wednesday at 1:59 AM, with the exception of the Thanksgiving & Christmas Day Contest Week and the Contest Week that immediately follows the Thanksgiving & Christmas Day Contest Week. The first Contest Week runs from Wednesday September 3, 2025, at 2:00 AM and ends on Wednesday September 10, 2025, at 1:59 AM. The Thanksgiving Day Contest Week begins at 2:00 AM on Tuesday, November 25, 2025, and ends at 1:59 AM on Friday, November 28, 2025. The Contest Week that immediately follows the Thanksgiving Day Contest Week begins at 2:00 AM on Friday, November 28, 2025, and ends at 1:59 AM on Wednesday, December 3, 2025.
 13. Selection Forms must be submitted during the Selection Window, which is defined as between 10:00 AM on Wednesday and 8:00 PM on Saturday of each Contest Week, except as set forth below. If an Entrant is selecting a team that is playing on a Saturday, the Selection Window is between 10:00 AM on Wednesday and 8:00 PM Friday for that Contest Week. The Selection Window for the Thanksgiving Day Contest Week is between 10:00 AM Tuesday November 25, 2025, and 8:00 PM on Wednesday, November 26, 2025. The Selection Window for the Contest Week following the Thanksgiving Day Contest Week will begin at 10:00 AM on Friday November 28, 2025, and end at 8:00 PM on Saturday November 30, 2025. Attempts to make selections outside of the applicable Selection Windows will be rejected. Any Entrant that fails to timely submit a Selection Form for a Contest Week, including Thanksgiving Day Contest Week and Christmas Day Contest Week, will be eliminated from the Contest.

14. Each Entrant may authorize up to one (1) Proxy to submit one or more of their weekly Selection Forms. Proxies must register in person at the Hollywood Casino at Greektown Sportsbook as a Proxy and must satisfy the age, eligibility and identification requirements set forth in these Rules. Hollywood Casino at Greektown does not officially endorse or recommend any proxy or proxy service and shall not be involved in, liable for, or participate in any proxy agreement under any circumstance. Furthermore, all Entrants assume sole liability and responsibility for submission of their weekly Selection Forms. Hollywood Casino at Greektown will under no circumstances act as a mediator between an Entrant and a Proxy.
15. Entrants and Proxies may submit Selection Forms either at the Hollywood Casino at Greektown Sportsbook desk or by email using the address provided on the initial Registration Form. Email submissions of Selection Forms must be sent to Aaron.Snyder@pennentertainment.com. Submissions of Selection Forms will only be accepted if received within the Selection Window. Failure to timely submit a Selection Form will result in elimination from the Contest.
16. By signing a Registration Form, an Entrant designates themselves as an "Official Contestant" and is the only person approved to claim and collect any prize awarded as a result of the Contest. Proxies are not eligible to collect any prize or monies for an Entrant.

18. Entrants/Proxies cannot void or make any changes to a Selection Form after it has been submitted to Hollywood Casino at Greektown Sportsbook. All requests to void or change a Selection Form after it has been submitted to Hollywood Casino at Greektown Sportsbook, whether in person or by email, will not be accepted and are deemed invalid.
19. Prize Structure and Determination of Contest Winner(s):

- a. The Contest prize(s) will be paid from the entry fees collected for the Contest. For example, if there are 90 Entries into the Contest, and the entry fee is \$500, the prize pool will be \$45,000. All prize payouts will be made in cash or by check.
- b. Hollywood Casino at Greentown Sportsbook reserves the right to limit the number of total Entries into the contest which will be set at one-hundred (100).
- c. The Contest Winner(s) is/are determined as follows:
 - i. At the conclusion of each Contest Week, all Entries with an incorrect selection will be eliminated from the Contest and deemed Inactive.
 - ii. If more than one Entry remains Active and at least one Contest Week remains, all remaining Active Entries continue to the next Contest Week.

 - iv. Under no circumstance will more than \$100,000 in total be awarded as an Undefeated Bonus Prize. Even if an Entrant submits more than one Entry that qualifies for an Undefeated Bonus Prize, the maximum amount that Entrant can win is \$100,000.
20. The Contest will be considered official after Week 8 of the 2025 NFL football season. If the NFL season does not run for at least eight (8) weeks, all Contest entry fees will be refunded. If the NFL season is not completed as scheduled, but lasts eight (8) weeks or more, all Active Entries remaining at the time of cancellation of the season will split the prize pool. If the NFL season is suspended (but not outright cancelled), the Contest will be suspended until the season resumes. If 90 days pass with no NFL game being completed, the Contest will end, and the entry fees will either be refunded (if before completion of Week 8) or the prize pool will be split equally amongst the last remaining Active Entries (if after Week 8).
